<b>WHAT DOES CUSO OF HAWAII SERVICES LLC DO WITH YOUR PERSONAL INFORMATION?</b>		
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li><input type="checkbox"/> Social Security number and account balances</li> <li><input type="checkbox"/> Account transactions and payment history</li> <li><input type="checkbox"/> Credit scores and credit history</li> </ul>	
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons CUSO OF HAWAII SERVICES LLC chooses to share; and whether you can limit this sharing.

<b>How does CUSO OF HAWAII SERVICES LLC protect my personal information?</b>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p><u>We also maintain other physical, electronic and procedural safeguards to protect this information and limit access to appropriate employees.</u></p>
<b>How does CUSO OF HAWAII SERVICES LLC collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li><input type="checkbox"/> open an account or apply for a loan</li> <li><input type="checkbox"/> give us your income or employment information</li> <li><input type="checkbox"/> give us your contact information or pay us by check</li> </ul> <p><u>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</u></p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li><input type="checkbox"/> sharing for affiliates' everyday business purposes-information about your creditworthiness</li> <li><input type="checkbox"/> affiliates from using your information to market to you</li> <li><input type="checkbox"/> sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choice will apply to everyone on your account - unless you tell us otherwise
<b>Definitions</b>	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p><u>Our affiliates include financial companies, such as Aloha Pacific FCU and Divisions of Aloha Pacific FCU; CU Coop Systems Inc.; CUSO of Hawaii Investments LLC.; CUSO of Hawaii Properties LLC. dba Aloha Pacific Premier Realty; HICUSO LLC</u></p>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <p><u>CUSO of Hawaii Services LLC does not share with our nonaffiliates so they can market to you.</u></p>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p><u>Our joint marketing partners include insurance companies.</u></p>
